Under-18 Competitor — Parent / Guardian Consent Form

Lilliput Sailing Club welcomes junior sailors at our regattas alongside our largely adult fleet. Because this event isn't run as a dedicated youth event, we ask every parent or guardian of a competitor under 18 to read this form and sign it before racing starts. It sets out what we need to know, and what we're asking you and your sailor to commit to for the event to run safely.

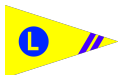

3. What we're asking you to confirm

Please read each point and tick to confirm. If something doesn't apply or you need further explanation, use the notes space at the end or speak to the Race Officer before signing.

- ☐ **Sailing ability** — my child has the sailing experience and boat-handling skill to compete in this fleet/class and race safely, including recovering from a capsize if applicable to their boat.
- ☐ **Swimming ability** — my child can swim at least 50 metres confidently, wearing the clothing/buoyancy aid they'll race in, and is comfortable in open water.
- ☐ **Event rules** — my child (and I) will comply with the Racing Rules of Sailing, the Notice of Race, the Sailing Instructions, and any other requirement set by Lilliput Sailing Club or the Race Committee, including reasonable instructions from race officials and safety boat crew.
- ☐ **Insurance** — the boat my child is sailing is covered by valid third-party liability insurance of at least £3,000,000, for the full duration of the event.
- ☐ **Medical** — to the best of my knowledge my child has no significant medical condition, allergy, or medication that could require attention during the event. (If this isn't the case, please give details below rather than ticking this box.)
- ☐ **Supervision & contact** — I (or another named responsible adult) will be on site — afloat or at the clubhouse — for the whole time my child is sailing or ashore at the event, and reachable on the mobile number given above.
- ☐ **Privacy & photos** — I have read and understood the Privacy Statement in the Notice of Race, and I'm aware that photos and video taken at the event may be used by the club (e.g. on our website, social media, or in event reports).
